

**Motor Vehicle
Report
Request and Submittal
Form**

As per the Utah DOT Rule R909-2-28 and Colorado DOT Rule 601-4 Chapter 5 Rule 500.5 , a Motor Vehicle Report (Drivers Record) must be supplied by the individual attending the Pilot/Escort Drivers Certification course. That document provides proof that the applicant currently holds a valid Operators/Driver's License. This report must show a date no less than 30 days prior to the date of the Pilot/Escort Driver Certification course being attended.

These MVR Reports must be obtained for the longest term (3 to 7 years -Utah) (5 years or longer – Colorado) provided by the Residency State DMV agency. Please Refer to UDOT and CDOT rules for disqualifying offences.

To obtain an MVR (Driving Record), an applicant has the following options:

1. The person may contact their individual State Department of Motor Vehicles to obtain this MVR Report.
2. USPilotCar can provide this service if the applicant so desires by completing the attached form. There is an additional fee for this service, and it is noted by state what this fee is. USPilotCar as part of this process is required to comply with the Federal Drivers Privacy Protection Act and as such, cannot duplicate, reproduce or disclose the contents of the MVR. If the applicant desires to have USPilotCar obtain the MVR, complete the following payment information page, and the attached application form. A clear copy of your driver's license must also be submitted with this documentation. NOTE: The picture on your license must be legible and able to tell that it is you.
